At such time the Board is so authorized, the meeting is being held for the necessary public purpose of considering a proposed budget for Fiscal Year 2020-2021, adopting resolutions related to the District's upcoming general election and internal controls policy, considering acceptance of the Fiscal Year 2019 audited financial report and any other business that may properly come before it, which are necessary for the proper operation of the District.
